

2014 Ariel Rosado Annual Bike Ride

The 2014 Ariel Rosado Annual Bike Ride will be held on Saturday 10th. May 2014. The Ride will begin at the Galen University Campus in Central Farm at 6:00 am and finish at Hour Bar and Grill at Newtown Barracks in Belize City. There will be refreshment breaks at Galen University Campus in Belmopan, Mile 31 on the George Price Highway and at Bisset's Boom Bypass Gas Station. The Ride will have official traffic escort and ambulance service.

Activities at the finish will commence at 11:00 am and include musical entertainment by the Imperial Band, sailing demonstrations by the Belize Sailing association, BBQ with refreshments for Riders who pre register and giveaways after the Riders arrive. Hour Bar and Grill will be operating a selling bar on the grounds and their regular services in the Restaurant. It will be a family fun day and all are invited to join in the festivities.

1. Riders are encouraged to Pre Register and collect non perishable entitlements to avoid Ride Morning Bottleneck. **BBQ plates will only be available for Riders who register before 5:00 pm on 5th. May 2014.**
2. All participants must sign the waiver form prior to registration
3. The following rules apply for the duration of the Ride
 - a) The official lead vehicle will maintain an average pace of 15 miles per hour and all riders and participating vehicles must remain behind the lead vehicle
 - b) All riders must obey the rules of the road i.e. stay in the right hand lane at all times
 - c) An official vehicle will coordinate the flow of overtaking traffic at regular intervals
 - d) Officials on motorcycles will regularly provide Riders with service, information and instructions. All Riders must heed such instructions in order to ensure a safe riding environment
4. Transportation to the start line can be provided by arrangement for a nominal fee.

For and in consideration of the undersigned participant's registration with the Ariel Rosado Foundation and being allowed to participate in the Ariel Rosado Annual Bike Ride and/or related activities, the participant (and the parent(s) or legal guardian(s) of participant, if applicable) waive(s), release(s) and relinquish(es) any and all claims for liability and cause(s) of action, including for personal injury, property damage or wrongful death occurring to participant, arising out of participation in the Ariel Rosado Annual Bike Ride and/or activities incidental thereto, whenever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant (and participant's parent(s) or legal guardian(s), if applicable) may have, are hereby waived, released and relinquished, and participant (and parent(s)/ guardian(s), if applicable) does(do) so on behalf of my/our participant's heirs, executors, administrators and assigns.

The Participant (and participant's parent(s)/guardian(s), if applicable) acknowledge(s), understand(s) and assume(s) all risks relating to cross country cycling and related activities, and understand(s) that the aforementioned activities involve serious risks to participant's person. I/We further acknowledge that there may be risks and dangers not known to the releasees or the participant or not reasonably foreseeable at this time.

It is the purpose of this agreement to exempt, waive and relieve the releasees from liability for personal injury, property damage, and wrongful death, including if caused by negligence, including the negligence, if any, of the releasees. "Releasees" include the foundation's board members, event organizers, event hosts, other participants, officials, advertisers and sponsors.

The Participant (and participant's parent(s)/guardian(s), if applicable) acknowledge(s) that he / she/ they have been provided and have read the above paragraphs and have not relied upon any representations of releases; that they are fully aware of the potential dangers of cross country cycling and understand that the signing of these waivers and releases are a condition precedent to participation in this event.
